At the centre on the T junction left and turn then immediate right signposted Llanon. Continue on this road for approximately 1 mile and on leaving Pontyberem, after a short distance, right into Sylen turn Road. Continue on this road for approximately 0.5 mile and the track will be found on the right hand side, turn right onto the track whereby the property will be located a third of a mile of the right hand side.
