Introduction

The plot (plot 2 on the plan) has the benefit of the full three year build allowance with the latest permission having been granted on the 22nd November 2018. The outline permission granted is for a detached house.

Planning permission

Outline planning permission was granted on the 22nd November 2018 with a 3 year expiration date. The permissions can be viewed on the Herefordshire Planning Portal using the application no. P181423/O.

Services

Location

This building plot is located in the popular hamlet of Bircher, which itself is on the doorstep of approximately 500 acres of beautiful National Trust land at Croft Castle. It offers superb walking and riding opportunities, and is also home to an abundance of wildlife. It is equidistance between the famous market towns of Ludlow and Leominster and also has the benefit of being in the catchment area of Wigmore High School. The larger market town of Leominster offers a wider range of amenities to include supermarkets, schooling, leisure facilities and good road and rail links to surrounding areas and nationwide.

The site is accessible for external observational purposes but all site visits should be booked with the agent.

Method of sale
